Some misconfusion about the Association role – looking for protection

□PSYCHOLOGISTS FEEL INSECURE WHEN THEY GUESS THEY HAVE TO DEAL WITH THE LEGAL SYSTEM

**PSYCHOLOGISTS HAVE HARD TO THINK ETHICALLY, USING THE PRINCIPLES** 

□PSYCHOLOGISTS ARE NOT MOTIVATED TO MAKE ETHICS FORMATION – WE ARE SEARCHING FOR SOLUTIONS
